The following data was synopsized from affidavits filed for the enrollment of individuals claiming citizenship in the Cherokee Nation. Approximate dates of birth and death are estimated from ages given in affidavits. In most cases, only children under the age of 21 were required to be named in applications. Unless otherwise indicated, the cases below were accepted by the Commissioner to the Five Civilized Tribes.
