Abstracted by James Pylant

The following data was synopsized from affidavits filed for the enrollment of individuals claiming citizenship in the Cherokee Nation. Approximate dates of birth and death are estimated from ages given in affidavits. In most cases, only children under the age of 21 were required to be named in applications. Unless otherwise indicated, the cases below were accepted by the Commissioner to the Five Civilized Tribes. Since Emeline J. Jones, a white woman, did not marry a citizen by blood of the Cherokee Nation was application for enrollment was denied. John B. Jones had acquired his citizenship in the Cherokee Nation on 7 November 1865 by an act of the Cherokee Nation Council, which declared that he was entitled to all rights allowable to white men under the constitution of the Cherokee Nation. The Department of the Interior ruled that since Emeline J. Jones was not a member of John B. Jones's family when he received citizenship, she was ineligible. However, this decision was reversed and her enrollment was accepted.

This is to certify that Revd Leonidas DOBSON formerly of Montgomery Square Philada and citizen of the U.S. has complied with the requirement of our laws "Regulating Intermarriage with white men," passed by the National Council and approved Oct 18th 1870, and has been recorded as a citizen in the Clerks office for Tahelequah Dist Cherokee Nation. She states that her husband was not married between the death of his former wife in '84 and his marrige to herself in '90, but she applied for children 17 and 14 and 12 years of age, which she she stated are children by this husband which shows that they lived together in some capacity before the marriage that is shown in the record. This discredits his whole conduct and throws doubts upon his status during the period intervening between deadt [sic] of his first wife and his declared marriage to his present wife...

John W. Gleeson stated that he and Clara Crittendon separated "because she had a negro baby after I married her, and the Cherokees told me...I had a right to quit her because she did not do right...never was divorced...She married again, her own coursin, after she had that negro baby, she left me altogether." However, her step-mother, Margaret Crittendon, stated that he never disputed being the father of her child. "He told her he wouldn't live with her anymore...carried all the stock with him."

John G. LIEBER, representative of the executors of Gleeson's estate, asserted that Lige KELLY, "a worthless scoundrel," laid claim to Gleeson's property. The Cherokee Nation contended that Gleeson was guilty of abandoning his wife and should not be enrolled as a citizen by intermarriage:

[It] is clear and conclusive that he left her, left without cause, took her cattle and attempted to dispose of them, and came back and told his wife that he did not intend to live with her and at that time no child, except the one born to them in lawful wedlock, had been born to them; that there was no dispute about the paternity of the child.

However, the Justice Department ruled that Gleeson's conflicting testimony was immaterial because of his citizenship on the Cherokee Roll of 1880, and that he was a resident of the nation at the passage of the act of June 28, 1898.
