# Cherokee-White Intermarriages

## PART VII

## Abstracted by James Pylant

The following data was synopsized from affidavits filed for the enrollment of individuals claiming citizenship in the Cherokee Nation. Approximate dates of birth and death are estimated from ages given in affidavits. When two wedding dates are given, it indicates that a Cherokee-White couple "remarried" after arriving in Indian Territory. In most cases, only children under the age of 21 were required to be named in applications. Unless otherwise indicated, the cases below were accepted by the Commissioner to the Five Civilized Tribes. The Commissioner to the Five Civilized Tribes ruled that, "....Cicero Johnson was not at the time of said marriage a recognized citizen by blood of the Cherokee Nation, and did not become such until his admission to citizenship in said Nation by the duly constituted authorities thereof November 15, 1876. Said Dovie Johnson did not, therefore, marry a citizen by blood of the Cherokee National prior to November 1, 1875. Application denied." The Secretary of the Interior reversed the decision.

The Commissioner to the Five Civilized Tribes determined that Andrew H. Norwood "forfeited, by his marriage in the year 1879 to Susan Love, who was a person not of Cherokee blood..." The Secretary of the Interior reversed the decision.

Testimony of James Wright, 14 May 1901 (via Simon R. WALKINGSTICK, interpreter). Testimony of Hattie Wright, 27 Oct. 1902; 20 Feb. 1907. Concerning her age, Hattie Wright stated: "I haven't got any education and I can't tell you exactly my age..."

Testimony of Joe FOX (b. Mar. 1846), a minister, 20 Feb. 1907. His testimony conflicted that of Mrs. Wright, by saying that the Wrights were married "about 32 years ago" [ca. 1875] at QUAH-LA-TAH's house, near Honey Creek, by Ben Hilderbrand. However, he recanted his testimony with the admission that the Wrights had lived together and had "two, or three, or four" children before marrying.

Testimony of Sarah MORGAN (age "about 71 or 73"), 20 Feb. 1907.

The Commissioner to the Five Civilized Tribes ruled that Hattie Wright was not entitled to enrollment in the Cherokee Nation. "In view of the foregoing it is considered that the evidence in this case is not sufficient to support a finding that the said James Wright and Hattie Wright were married prior to November 1, 1878." The Secretary of the Interior reversed the decision.

The Commissioner of the Five Civilized Tribes ruled that Amanda Beck was not eligible for enrollment in the Cherokee Nation. "...The evidence further shows that said Amanda Beck was married prior to the said David M. Beck, and fails to show that her former husband was dead, but affirmatively shows that she had not been divorced from him ar the time of her marriage to the said David M. Beck..." The Secretary of the Interior (in view of the opinion of the Attorney General in the John W. Gleason case) enrolled David Beck as a citizen by intermarriage."

The Commissioner to the Five Civilized Tribes ruled that Osburn J. Byrd was not entitled to enrollment in the Cherokee Nation. His wife, a Shawnee, "acquired her right to enrollment as a citizen of the Cherokee Nation by virtue of her compliance with the provisions of the agreement entered into by the Cherokee and Shawnee tribes of Indians of June 7, 1869." She was not, therefore, a citizen of the Cherokee Nation by Cherokee blood. The Secretary of the Interior reversed the decision.

Letter dated 7 Jan. 1907 to the Commission to the Five Civilized Tribes by Daniel "Dick" Harmon stated that he was a Creek Indian, not "white intermarried." Mr. Harmon stated that he had been brought to the Creek Nation from Mobile, Alabama, "with a good many other Creeks Indians by Wm. McMaston & Ward Coachman in 1847... I will give you the names of my mother Henreitta Harmon my brothers Benjamin Harmon and William Harmon and myself My name is Daniel Harmon they alway call me Dick. we all cam[e] to Creek Nation together when I was a small boy. I have some strong evidence that is my nephews Ben & Dan Harmon bothehave filed on land in the Creek Nation my grand children also filed up there whos[e] names are as foll[o]ws Fred Boles, Holland Boles Pearl Boles Cherokee Boles Ruby Boles Henrietta Boles. They live near Broken Arrow their Mother's name was Jennie Boles who was my daughter My wife has no Creek blood neather has Frank Boles the farther of my grandchildren then where did they get their right by me as a matter of fact...

The Commissioner of the Five Civilized Tribes ruled that Daniel Harmon was ineligible for enrollment in the Cherokee Nation. His marriage "was not in accordance with Cherokee law, the said Daniel Harmon having failed to secure a license as required by the laws of the Cherokee Nation..." The Department of the Interior reversed the decision.

"It is considered that there is not sufficient evidence in this case to support a finding that the applicant was married to her Cherokee husband prior to November 1, 1875..." The Secretary of the Interior reversed the decision.

Although he was a citizen of the Cherokee Nation, he was not of Cherokee blood. However, the decision was reversed by the Secretary of the Interior.

The Commissioner to the Five Civilized Tribes ruled that, "Andrew V. Jordan died in the State of Texas without becoming a citizen of the Cherokee Nation; that in 1878 the said Sarah A. Jordan removed to the Cherokee Nation, and the said applicant does not claim to have been admitted to citizenship in the Cherokee Nation until the year 1879. Said applicant did not, therefore, marry a recognized citizen by blood of the Cherokee Nation prior to November 1, 1875." The decision was reversed by the Secretary of the Interior.

\*Mr. Thompson stated that he was absent from the Cherokee Nation from the Fall of 1874 to 1879, during which time resided in Atlanta, Georgia, "visiting my family relations." His father died there in 1879. In Georgia, Mr. Thompson operated a mercantile business and blacksmith shop.

The Commissioner to the Five Civilized Tribes ruled that Robert H. F. Thompson, "by reason of his removal from the Cherokee Nation and his continued residence in the State of Georgia for a period of four or five years," denied his enrollment. This decision was rescinded by the Secretary of the Interior due to Thompson's name on the 1880 enrollment.

Note: The application of E. A. Welch was made by Emmet Starr, a 31 year-old Cherokee, on 30 June 1902. The Commissioner to the Five Civilized Tribes requested the address of E. A. Welch from her ex-husband, John E. Welch. The following is a transcript of his reply:

Coffeyville Kans

Dec. 23rd 1902

Hon L. B. Bell

Muskogee

Dear Sir

I thought I would write you a few lines this morning. The Commissioner wanted to know where the address of E. A. Welch, who was enrolled on the Rolls of 1880, was, This woman was then my wife. In 81 (I think) She was Divorced from me, in Flint District Hon Steve Tehee was the presiding Judge at that time.

Soon after this woman was Divorced from me, She married William Wright,

Soon after this woman was Divorced from me, She married William Wright who ran a Black Smith shop on the Old George Starr farm, in Flint District and now living at the Saline Court House. Rose is their Post office.

I called your attention to this fact thinking perhaps you might know Something in regard to the matter yourSelf.

S[h]ould their be any thing else needed in regard to my wife and Children being enrolled, please inform me, and I will take it as a great favor.

The following is a transcript of Mrs. Wright's response to the Commissioner's inquiry:

Rose I. T. Nov. 4 1873

To the Commission of the five Civilized tribs in answering to your question I am the person whos name appears on the roll of 1880 and that I sepperated from John E. Welch and that I married a white man and forfited my citizenship I havent made any application for enrolement what ever now I would be glad the Commison would inform me who made the application.

The Commissioner to the Five Civilized Tribes ruled that E. A. Welch was not eligible for enrollment, stating "that the application was made by Emmet Starr, apparently without her knowledge or authority." However, the Secretary of the Interior granted the application.

The Commissioner of the Five Civilized Tribes ruled that Martha Randolph forfeited her enrollment by reason of her remarriage to a non-citizen of the Cherokee Nation. The decision was reversed by the Secretary of the Interior.
