Cherokee-White Intermarriages

Part VIII

Abstracted by James Pylant

The following data was synopsized from affidavits filed for the enrollment of individuals claiming citizenship in the Cherokee Nation. Approximate dates of birth are estimated from ages given in affidavits. When two wedding dates are given, it indicates that a Cherokee-White couple "remar ried" after arriving in Indian Territory. In most cases, only children under the age of 21 were re- quired to be named in applications. Unless otherwise indicated, the cases below were accepted by the Commissioner to the Five Civilized Tribes. She stayed around for a while and then married a dutchman named Lewis [Bowers]. . . a few months, and then in a year or two she took up iwth a man by the name of KA-LA-NE-SHE. . . about two years. . .she was living with this last man, named Joe PYLE--I think she married him according to the law.

According to Wilson Ryder, "Lafayette Catron and his mother kept house, and the children stayed there with their granny. Lafayatte Catron and his mother together raised them, but Nancy Roach throwed the children away."

"This decision was protested by the Cherokee Nation, contending that "he never became a citizen of the Cherokee Nation after his marriage prior to 1888, and it is contended on behalf of the CHerokee Nation that he, not b3ing a citizen of the Cherokee Nation on 1 November 1, 1875, could not confer rights by intermarriage upon his wife, Martha A. Reaves."
