Part XI . Conclusion

Abstracted by James Pylant

The following data was synopsized from affidavits filed for the enrollment of individuals claiming citizenship in the Cherokee Nation. Approximate dates of birth are estimated from ages given in affidavits. When two wedding dates are given, it indicates that a Cherokee-White couple "remarried" after arriving in Indian Territory. In most cases, only children under the age of 21 were required to be named in applications. Unless otherwise indicated, the cases below were accepted by the Commissioner to the Five Civilized Tribes. The Cherokee Nation protested the decision of the Department of the Interior to accept Mary Crittenden's application because her marriage was illegal. "The testimony in this case shows that Mary Crittenden, nee Weaver, is a colored person... The testimony further shows that she is a full sister of Bullette Weaver who is classified as a colored man and not as a white person or a Cherokee by blood." However, the Department of the Interior did not reverse its decision, as the 1880 tribal roll showed Mary Weaver and her parents were shown as Cherokees by blood. The Cherokee Nation stated: "Whereas Mary Crittenden was born in 1847 or 13 years before the roll of 1880 was made and there is no evidence that she was ever recognized by Joe Weaver as his child, but on the other hand there is evidence that her mother was a woman of loose morals, was never married to any man, but had numerous other children..."
