## Widows' Dowers of the 1820s in Washington County, Tennessee

Transcribed by Gary R. Toms and William R. Gann of the Gann Historical Society and Library

These dowers were found among the loose court papers of Washington County, Tennessee, which are housed in the Archives of Appalachia in Sherrod Library, East Tennessee State University, Johnson City, Tennessee. These are transcribed from photocopies of the original documents. Every attempt has been made to keep the original spelling and punctuation, even though this has meant retaining obvious errors.

The value of these dowers from the period 1820 to 1829 differs from those of the 1840s which appeared in the Jan.-Feb./Mar.-Apr. 1996 issue. In these dowers, there appears to be a strong emphasis on describing the land, using the metes and bounds measurements of that period. This is in contrast to those of the 1840s which appeared to be primarily concerned with providing the widow and her family with supplies to sustain them for one year while the estate was in probate. Even so, these dowers concerned primarily with land have considerable value for the genealogist. There is the obvious value of specifically naming the widow and giving a date by which her husband was deceased. Secondly, the names of other heirs of the deceased and often the adjacent landowners may be given.

Of particular interest in transcribing this series of dowers was the treatment of surnames. There are several good examples in these documents of surname variations where the same name may be spelled two, three or more different ways in the course of a document. This underscores once again the need for the researcher to always be open to surname spelling variations and to check every possibility.

These dower rights were found in one specific group of loose court papers in the Washington County Court Records collection at the Archives of Appalachia. These dowers were found in Series D-II, Judicial Records, 1780-1939, Box 235. Additional documents of this type exist for Washington County and will be transcribed for future issues.

NOTE: The "style" of the case, or other notes from the reverse side of the dower, are transcribed only when they provide different or additional information from what is contained in the main text of the dower.

Course and Distance of the widows Dower part of the **Smith** plantation, Beginning at a white oak near a road and Barn, thence up a lane North fifty eight west thirty six poles to a Stake in said lane thence through a field South thirty nine West Sixty seven poles to a black oak corner of Jobe Powels part of said plantation thence with his line North fifty eight West forty poles to two black oak and a white oak thence North thirty nine East ninety nine poles to a Stake where a Thorn Bush formerly stood thence South Seventy East fifty eight poles to a Stake thence a Straight line to the beginning containing thirty three acres and one third of an acre.

Course and Distance of Jobe Powels part laid off for him on the Smith plantation—Beginning at a white oak corner of the widows dower part thence South forty six East Twenty three poles to a Stake near a marked black

[oak?] Henry Marshes corner thence with his line South fifty west one hundred and Twenty poles to a stake corner of a part of said place laid off for Henry Powel thence with his line North Sixty three West seventy poles to a double white oak thence North thirty nine East Sixty four poles to two black oak and a white oak corner of the widows part, thence with her line South fifty eight East forty poles to a black oak thence North thirty nine East Sixty seven poles to her corner stake in the lane, thence with said lane South fifty eight East thirty six poles to the beginning containing fifty two acres.

Course and distance of Henry Powels part of the Smith plantation Beginnning at a Stake and a white oak thence North Sixty three West Sixty two and a half poles to a Stake where a Sourwood formerly stood thence North thirty nine East thirty six poles to double white oak Jobe Powels corner thence with his line South Sixty three East Seventy poles to stake said Jobes corner thence South fifty three West forty poles to the Beginnning containing Fifteen acres



We have laid off to Hannah Miller one of the Heirs Lot No. 2 containing twenty eight acres. Begining at a percimmon on Fancelers line a corner of No. 1 thence north five poles to two white oaks Fancelers & the Heirs of Robert Maclins corner thence with the line of Maclins heirs North fifty degrees East twenty four poles to a white oak thence South fifty seven degrees East one hundred and Sixty four poles to a white oak thence South Eleven and an half degrees West Six poles to a Stake & pointers thence South Sixty one degrees West twenty one poles to four hickories and a black oak thence North fifty seven West one hundred & Sixty poles to the Begining

We have laid off for Jane Miller one of the Heirs Lot marked No. 3 Containing twenty eight and an half acres Begining at a white oak a corner of Lot No. 2 thence North Eleven and an half degrees East thirty poles to a white oak & pointers thence North fifty seven West one hundred and forty six poles to a white oak on a line of R. McLins Heirs thence South fifty West thirty poles to a white oak thence South fifty seven East one hundred and sixty-four poles to the Begining

We have laid off for Hariett Miller one of the Heirs Lot No. 4 containing thirty five acres. Begining at a white oak and post oak corner of No. 3 thence North Eleven and an half degrees East forty eight poles to a white and pointers thence North fifty seven West one hundred and fourteen poles to a Stake and pointers on a line of R. McLins Heirs thence with the same South fifty West forty eight poles to a white oak thence South fifty seven East one hundred and Sixty four poles to the Begining

We have laid off for Rachel Holmes formerly Rachel Miller one of the Heirs Lot No. 5. Containing twenty nine acres. Begining at a Stake near a marked white oak corner of Lot No. 6. thence South Eleven and an half West fifty poles to a white oak and pointers corner of Lot No. 4. thence North fifty Seven East one hundred and fourteen poles crossing the middle of the Spring to a Stake & pointers on R. M Lins line thence North fifty East fifty poles to a Stake near a white oak pointer thence South fifty Seven East eighty two poles to the Begining

We have laid off for Nancy Giddeon formerly Nancy Miller one of the Heirs The Lot marked No. 6. Containing twenty four acres Begining at a black oak the Begining corner of the whole Tract and a corner of Christian Zettys land thence North forty degrees West forty poles to a Stake and white oak in Line of a red oak and white oak called for in the Grant a corner of the land of the heirs of John Barkley and Robert M Lin thence South fifty West Seventy five poles to a Stake near a white oak pointer corner of Lot No 5 thence with a line of the Same South fifty Seven East eighty two poles to a Stake near a marked white oak thence North Eleven and an half East Sixty Six poles to the Begining
